Personal Data We Collect We may collect personal data from employees, customers, suppliers, visitors, business partners, and third parties through:- Company units, offices, and representatives- Dealers, websites, social media channels, and mobile applications- Call centers, training programs, seminars, and events Types of personal data may include:- Identity information (name, surname, ID number)- Contact information (email, phone, address)- Employment and professional details- Financial and transaction data- Technical and device information.
- 3. Purpose of Data Collection and Processing We process personal data for purposes such as:- Ensuring business continuity, commercial, and legal security- IT operations, logistics, and after-sales support-Product and service improvement, development, and marketing- Communication and cooperation among affiliated companies- Visitor management and workplace safety- Compliance with legal obligations and regulatory reporting Processing is conducted in accordance with Articles 5 and 6 of KVKK.
- 4. Sharing and Transferring Personal Data Your data may be shared with: a) Service Providers: Banks, logistics partners, IT providers, and other authorized service providers to ensure smooth and complete service delivery. b) Legal and Regulatory Authorities: Public institutions or authorities as required by law, judicial decisions, or administrative orders. c) Consulting and Support Services: Lawyers, consultants, auditors, and financial or tax advisors to protect rights and ensure compliance. d) Marketing and Advertisers: Anonymized data may be shared for marketing purposes to target audiences without identifying individuals. e) Domestic and International Transfer: Your personal data may be transferred to affiliated companies or business partners, both inside and outside Turkey, as legally permitted.
- 5. Legal Basis for Processing We process personal data based on:- Your explicit consent- Fulfillment of legal obligations- Contractual necessity- Legitimate interests such as business security, customer relations, and operational efficiency
- 6. Your Rights Under KVKK As a personal data owner, you have the following rights: 1. Learn whether your personal data is processed 2. Request information about your processed data 3. Know the purpose of processing and whether it is used accordingly 4. Discover third parties to whom your data is transferred 5. Request correction of incomplete or inaccurate data and notify third parties 6. Request deletion or destruction of data once processing purpose no longer applies 7. Object to automated decision-making that produces legal or similar effects 8. Claim compensation if personal data is unlawfully processed
